Daycare Rules and regulations:

- We accept dogs of all ages. Puppies must be over 12 weeks and on a vaccination program. Puppies or shelter dogs must have been in the home for at least two weeks prior to attending daycare.
- All dogs over the age of 6 months must be spayed or neutered (exceptions made in advance of stay)
- All dogs require up to date vaccinations for rabies, DHLPP, and bordetella. Proof of vaccination or titer testing is required.
- Dogs that are currently ill or injured are not permitted at daycare. Dogs who have recovered from a communicable illness within the past 30 days must provide veterinary clearance to return to daycare. Owners certify by signing this application that their dog is in good health.
- If your dog incurs veterinary bills during their stay at daycare you, the legal owner of the animal, must pay those bills at time of pickup. Howl a Day Den, LLC reserve the right to seek veterinary care for your dog at its discretion.
- All dogs must be non-aggressive and not food or toy possessive. Owners certify by signing this application that their dog has no history of threatening or harming any person or animal.
- We reserve the right to refuse any dog for any reason at any time.
- Pick-ups for daycare clients must be completed by 6:00 PM. Late fees for late pick-ups do apply at a rate of \$15.00 for every 15 minutes past 6:00 PM. No exceptions.
- Daycare passes have no cash value and are non-refundable. No exceptions.

Waiver and Agreement

1. I hereby represent that I am the legal owner of the dog(s) described above to use the services provided by Howl A Day Den, LLC.
2. I hereby waive and release Howl A Day Den, LLC, it's employees, directors, owners and agents from any and all liability which my dog(s) may suffer, including specifically, but not without limitation, any injury or damage whatsoever arising from the dog(s) attendance and participation of services provided by Howl A Day Den, LLC.
3. I hereby agree to indemnify and hold harmless Howl A Day Den, LLC; it's employees, directors, owners and agents from any and all claims by any member of my family or any other person accompanying me to a function of Howl A Day Den, LLC, or while attending the premises thereof, as a result of any action by any dog.
4. I hereby represent that my dog(s) is of good health and has not been ill with any known contagious diseases within the past 30 days.
5. I recognize that the health of the dog(s) is the owner's responsibility. I hereby represent that all required vaccinations (rabies, bordetella, distemper and parvovirus) are up to date. I will also continue to ensure that the required vaccinations will be kept up to date for as long as my dog(s) attends Howl A Day Den, LLC. In addition, I hereby represent that my dogs have flea/tick preventative treatments applied regularly.
6. I further understand and agree that in admitting my dog(s), Howl A Day Den, LLC has relied on my representation that my dog(s) is in good health and has not harmed, shown aggression or threatening behavior towards any other person or any other dog.
7. I further understand and agree that Howl A Day Den, LLC and their caregivers will not be held liable for any problems that might develop with my dog(s) including, but not limited to sickness, disease, injury, running away and death, provided that reasonable care and precautions are followed.
8. I understand and agree that any problem that develops with my dog(s) will be treated as deemed best by the care-givers of Howl A Day Den, LLC at their sole discretion and that I assume full financial responsibility for any and all expenses incurred.
9. Howl A Day Den, LLC's fees and packages are non-refundable and non-transferable.

10. I agree that my dog(s) may be videotaped, photographed and or recorded. Howl A Day Den, LLC shall be the exclusive owner to the results and all proceeds of such media.

11. Howl A Day Den, LLC reserves the right to permanently remove a dog from care at any time to ensure the safety of other dogs as well as staff.

12. I understand that the rules above apply to any dog(s) attending overnight boarding, daycare and grooming services.

13. This Agreement is ongoing and applies to all services and visits now and in the future. It shall remain in full force and effect unless and until it is replaced by a subsequent written agreement signed by the Client.
